BOATING REPORT

LAKE MAP - James gave a report on the map project. He showed us draft #2. He is waiting for Harrisburg's file for trails. It took 50 hours to gather data on the lake. It was presented at IUP last week. Depths goes to about 35 feet deep. He was able to calculate the volume – around 300 mil cubic feet. The lake is about 709 acres. Should be done by July $1^{\rm st}$. Ben has some people who may sponsor it. Can possibly ask \$100 or \$500 dollars depending on the space available.

- Discussion on options for printing:
 - One option is the 4 page spiral bound. It would be on water proof, tear proof paper – one would 5-6 dollars per map. Kelly got other prices from the gazette that was a little higher. \$1,500 for 250 maps.
 - Second option is the foldable map. This would be a 36x24 size map on water proof paper. All decided on this option. We should get a minimum of 250 maps. Gazette prices were about 15.00 per map for a hundred (100) maps. Total of \$1,500. Will be more for double sided.
 - Kelly will get a new quote for the size we want, 36x24, tear resistant, waterproof paper,
 - 4.7-5.7 mil., double sided.
 - We could do a fishing map on one side, a trail map also.
 - o We could also offer the second option map that is not folded for the wall.
 - Allegheny Anglers may be able to do a bass tournament with proceeds to go to making the maps. Ken will contact them to find out if it is possible.
 - o Ken will check to see if the tourist bureau will help with the printing.
 - Sponsors for the map could get 2x3 or 3x4 ads for a \$500. 00 donation.
 James will need a jpeg image from the sponsor. High resolution. He will tell us how many sponsors we can fit. Non profit may be at a different price than for profit.
 - James will work on what fits on the map.
 - James has questions for Ken he will need to go over.
 - o lames will do the next draft and share it with us for input.
 - What else do we want on the map? Directions? Fishing regs, invasive species to be aware of, leave no trace, emergency, ADA info, history, cool facts, biking info or rules, FOYC mission statement and web site. James will need this info soon. Everyone needs to think about it and get back to him at james.whitacre@gmail.com
 - o Target date for printing is by the end of July.
 - Copywriting? James would like to have FOYC get this copyrighted with James as the author and to have rights to use it in the future.
